Accordingly, having taken note of the news item and more particularly having regard to the photographs published with the said report, we are inclined to issue a Suo Moto Rule in the following terms:

Having perused the application and having considered the submission of the learned Advocate for the applicant, we are of the view that the applicant's appearance is necessary as an Intervenor and his addition is necessary for proper adjudication of the matter.

Accordingly, the application is allowed.




